- 2. Educational Aid (we have all the classes needed for this program)
- 3. Bilingual Educational Aid (we need three more classes for this program)
- 4. Medical Assisting (back office)
- 5. Digital Arts/Graphic Design

Jessica presented the chart she created with different programs that we may consider, what courses we need to add for these programs, salary information, neighboring colleges that offer these programs, etc. She also shared her goal of expanding programs to include more CTE courses. Vicki mentioned that we may also consider making majors such as Pre-Dental Hygiene or Pre-Engineering. Jessica briefly discussed the CTE survey that is sent out in January, and that we should incentivize survey completion so we will get more responses.
